They were very helpful and gave good tips to improve our writing



It really shaped my way into doing researching into company's and giving them a complete overview





I feel like I fully understand how to conduct a swat analysis and do research to properly support my claims


The reason I felt better prepared was because she had given us all the resources we need to use and after her lecture, I had a better understanding of what I wanted to ask her for the interview.

Discuss three things you learned about non-profit organizations by researching for and completing the SWOT Analysis. Note: "I didn't learn anything" or "I don't know" is not an appropriate answer.

Yes

I have learned about stakeholders and stockholders and what they are and what they do to contribute to non-profit organizations.

I learned that non profits have different strategies and tactics that they use to conduct business.

I never knew just how tight budgets were for non-profits. The SWOT analysis made it apparent the library wanted to make changes, but never had the funds to do so. I also never realized how expensive necessities cost and take out of the budget. The library's biggest expense is database subscriptions; something a college library probably couldn't survive without. Finally, the SWOT analysis made it very apparent that the employees, especially Sara love their jobs and don't necessarily "work for the money." Everyone at the Taylor Memorial Library is dedicated to helping everyone who walks through their doors.

One big thing I learned is that it is not always easy for nonprofit organizations to make the necessary changes due to lack of funding.

1. Nonprofits are tax-exempt or charitable

- 2. Public confidence is a factor in the amount of money that a nonprofit organization is able to raise
- 3. Nonprofits often make money, but what they do with the money they make separates them from for-profit businesses.

it can be hard to have the funding for the projects they want to put on, enough staff, and building updates.

I learned that non-profit organizations are very limited because of funding, but that the money they do spend goes towards the profits purpose, not toward a salary benefit. I learned that they often are very inspired to help people.

I learned that there are a lot of different challenges faced by every company. I learned that though many companies have strengths, there are weaknesses that can bring the company down if they aren't handled. Lastly, I learned that some issues or threats are not controllable and happen because of everyday life, so new inventions or ideas need to rise up to fix those issues.

First is the teamwork those organizations create while working. Second, they set goals they aspire to achieve. They always want to do better than the following year. Last always take time to get to know their customers.

The founders do not make money off it, but they spend the money they earn to improve themselves. They often aim to achieve a common purpose at a community, local, state, national, or even global level. They also provide help and/or resources to a target audience with a specific need.

I've learned about the financial aspect of non-profits. I've learned in my research about different grants and how it's what

gets non-profits off the ground.

Non-profit organizations are focused on their mission more than making a profit. However, they still need to be making a profit in order to be successful.

I learned how none-profit organization get their money from, how those organizations have to analyze where are they putting their money towards to because that money comes from donations and other different resources. certain luxuries can not be given.

It is very difficult to budget, the business is carefully run to ensure money is not lost, and nonprofit organizations are hard to keep staffed

Doing the SWOT Analysis allowed me to break down how the different organizations worked. The SWOT is a good way to see where a company or in this case a non-profit organization is lacking and what they want to improve. This can help with the organization's goals. It allows an organization to access what resources they have and to find success within the resources provided. Looking at the SWOT Analysis of another company or non-profit allows an organization to see how they can improve (benchmarking). The SWOT is a simplistic way for a company to be realistic and analyze where they are as a company, then plan a strategy for the future.

The three things I learned about non-profits through my analysis is that they play a role in the economy. Even though they are non-profit they still have to pay wages.

I learned how to use the online database, and about the Instruction Department. I also learned about the variety of expertise among the employees, and how they are all available to help students.



The library database is very helpful when researching for scholarly sources and peer reviewed articles.

It is different from searching google because it feels more legit than articles on google.

Google obviously gives you everything ever published on a certain topic, where say Ebsco is more reputable with peer reviewed sources, links to full text journals or papers, etc. Sometimes Ebsco can be tricky because you don't always need to read a whole scholarly research paper on what your researching, but when you need to, it's the best option.

When using a database offered through a library you know that it is a real, reliable sources opposed to just searching on Google. I was able to find plenty of resources I wanted through the library databases. Sometimes it took a little bit of searching but they were there.
